Tender will be opened on 19.07.2016 at 1.30 PM at the office of the undersigned. The envelope must be properly superscribed with "Tender documents for NIT No. _____". All the tenderers or their authorized representatives are requested to be present on the aforesaid opening date and time personally.

List of essential documents to be submitted for qualification:-

1. Demand draft of EMD for Rs. 5,000/- or valid and item specific exemption certificate.
2. Copy of Pan Card of the bidder.
3. Copy of valid Trade License.
4. Copies of Income Tax return for the last three years (Assessment Years: 2013-14, 2014-15 & 2015-16).
5. Copy of VAT registration certificate.
6. Copy of up to date VAT clearance Certificate for the last quarters of last two years (2014-15 & 2016).
7. Copy of Profit & Loss A/c. and Balance Sheet for the last two years (2014-15 & 2016).

The tender documents must be submitted in two bid method:-

One sealed envelope (Envelope A) containing E.M.D and technical papers along with a filled up check list of documents; & Another sealed envelope (Envelope B) containing price bid only.
